The Boys & Girls Club, in partnership with Sylvan Learning Center and in cooperation with Kailua Intermediate School, is offering FREE tutoring to Windward Clubhouse members who attend Kailua Intermediate School. Sylvan Learning's Ace it! Program will help your child succeed in school and strengthen their reading and/or mathematics skills. This program will take place at the Windward Clubhouse during morning Action Period on Monday, Tuesday, Thursday & Friday.

To determine if your child qualifies for this opportunity, he/she must complete both a reading and a math pretest and be a member of the Boys & Girls Club. If he/she qualifies for the program, you will be notified and can decide if your child can commit to the entire 30 hour program and thus either accept or decline his/her position in the program. *Since positions are limited, we request that your child only applies if you are strongly considering participating in the program.*

Classes will be held from February 2nd to May 13th from 7:55am to 8:45am (before school and running through Action Period). Snacks will be given to your child when they attend the tutoring sessions. Your child's progress will be charted and shared with you upon completion of the program.

Your child must complete BOTH a reading and math pretest. **Please submit your form in person to the Windward Clubhouse by Thursday, January 21st.**
